

**LAKE REGION ANGLERS ASSOCIATION ADULT-CHILD TOURNAMENT**

**SATURDAY JULY 15th, 2017**

**LOCATION**

Grahams Island Landing—Sievert Center

**FISHING AREA**

Outing boundaries will be all navigable waters on Devils Lake only. All boats will leave the ramp under a single file controlled start beginning with the boat registered #1.

**FISHING HOURS**

The outing fishing hours will run from 9AM to 3PM.

**ELIGIBILITY**

An eligible fishing team shall be made up of 2 to 4 persons, however there is a maximum of only one adult angler allowed per each youthful angler. Persons of any age are eligible to enter but one team member must be of age 18 years old or older. All persons must be members of LRAA.

**REGULATIONS**

All contestants must observe US Coast Guard and ND Game & Fish Dept. rules, regulations, laws and license requirements. Life preservers must be worn when boat is on plane. All teams are responsible for their fish following the outing. Contestants are reminded that the "Spirit of the Rule" will prevail in all judgment cases.

**REGISTRATION—ENTRIES—WEIGH-IN—PRE-REGISTRATION REQUESTED**

Teams must register prior to the outing scheduled time. No late entries will be allowed. Each team will undergo a boat check and be issued a team number. At the weigh-in one member of the team must deliver their number to the scoreboard, even if the team does not have any fish to weigh. The team may then load out their boat and proceed to weigh-in

**AQUATIC NUISANCE SPECIES INSPECTION**

All boats must be inspected for ANS prior to doing any fishing or entry into a LRAA outing. Anglers will be required to sign-off on a ANS questionnaire form during registration prior to fishing in LRAA outing.

**ENTRY FEES**

Entry fee shall be \$5.00 per person. Checks should be made payable to LRAA. In the event of cancellation due to inclement weather the Outing will be held the following Sunday. If the Outing is cancelled all entry fees will be refunded. The Outing is limited to 49 participants. Listen to local radio stations for cancellation and rescheduling information.

**SCORING**

Team standings shall be determined by a total weight of their chosen 5 northern pike, 5 walleye and or 5 White Bass, Perch or Crappie. There will not be a minimum length of the fish. The team limit will be a total of 7 Walleye, 7 Northern Pike and or 7 White Bass, Perch, or Crappie. Once the 7th fish of tournament designated species are placed in the live-well the teams fishing day will be complete. Any ties will be determined by the largest walleye. There will be no early weigh-in unless arrangements have been made with Outing directors.

**PRIZES**

Plaques will be awarded to the top 10 youth teams based on total weight and one plaque to the angler team with the largest Northern, Walleye and White Bass. Each child entered will receive a participation award. Light dinner will be served after the event.
