

## TOURNAMENT PRIZES

### Spring Northern/Walleye, East Bay & Open Tournaments:

Two plaques per team will be awarded to the top 3 teams (top 5 teams for the DL Open) based on total weight, plus one plaque for the angler team with the heaviest weight Northern Pike & Walleye.

**Walleye Widow & Adult / Child Tournament:** Two plaques per team, one for each female (Walleye Widow) and youth (Adult-Child) angler will be awarded to the top 5 teams based on total weight, plus one plaque for the angler team with the heaviest weight Northern Pike, Walleye & White Bass. A light lunch will be served after the event.

**Prize & Cash Payouts:** Cash payout to be awarded to the top 3 teams based on 75% of the entry fees received using the following formula: 50% 1st Place; 30% 2nd Place; and 20% for 3rd Place in the Spring Northern/Walleye, East Bay, Devils Lake Open & Walleye Widow Tournaments. For the Adult-Child Tournament prizes will be awarded to each of the youth anglers purchased from the 75% of the entry fees received.

## ENTRY FEES

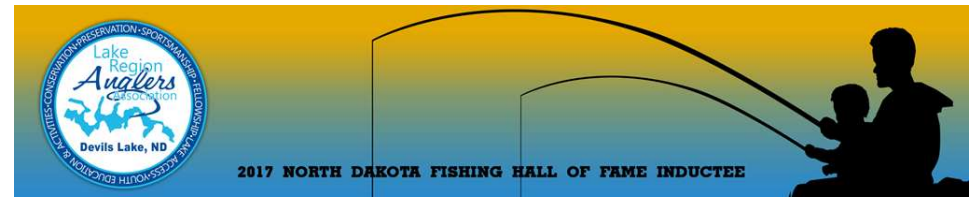
**Spring Northern/Walleye & East Bay:** \$25.00 per team.

**DL Open:** \$50.00 per team.

**Adult / Child:** \$5.00 per person.

**Walleye Widow:** \$25.00 per couple.

## FISHING AREAS

Boundaries will be all navigable waters on Devils Lake only. All boats will leave the ramp under a single file controlled start beginning with the boat registered #1.

**Exception: East Bay Tournament:** Boundaries will be all navigable waters on Devils Lake EAST of Hwy 20 ONLY.

## ELIGIBILITY

**Spring Northern/Walleye, East Bay & DL Open:** An eligible fishing team shall be made up of 1-2 or 3 persons. Persons of any age are eligible to enter, but one team member must be at least 18+ years old. All persons must be members of LRAA. **See the "Team of the Year" Qualifying Criteria - Rules - Scoring document located on LRAA's website under the heading "Tournaments" for the complete guidelines on the TOY competition.**

**Adult / Child:** An eligible fishing team shall be made up of 2 - 4 persons, however there is a maximum of only one adult angler allowed per each youth angler. Persons of any age are eligible to enter, but one team member must be at least 18+ years old. All persons must be member of LRAA.

**Walleye Widow:** Eligible fishing teams shall be made up of 1 male & 1 female, or 2 males and 2 females. Persons of any age are eligible to enter, but one team member must be at least 18+ years old. All persons must be member of LRAA.

## REGULATIONS

All contestants must observe US Coast Guard and ND Game & Fish Dept. rules, regulations, laws & license requirements. Life preservers must be worn when boat is on plane. All teams are responsible for their fish following the tournament. Contestants are reminded that the "Spirit of the Rule" will prevail in all judgement cases.

## REGISTRATION • ENTRIES • WEIGH-IN PRE-REGISTRATION REQUESTS

Teams must register prior to the tournament scheduled time. No late entries will be allowed. Each team will be issued a team number. At the weigh-in, one member of the team must deliver their number to the scoreboard, even if the team does not have any fish to weigh. The team may then load out their boat & proceed to weigh-in their catch.

## AQUATIC NUISANCE SPECIES

**All watercraft not licensed in this state** and operated on North Dakota waters must annually obtain a valid, nonrefundable aquatic nuisance species sticker. This ANS sticker must be placed on the starboard side of the watercraft within 6 inches of the registration number and displayed within 10 days of purchase. Each licensed watercraft is listed on the purchase receipt. A copy of the purchase receipt is proof of validation until the sticker is received via postal mail.

## SCORING

Team standings based the total weight of fish.

**The Spring Northern & Walleye, The East Bay and The DL Open** Tournaments boat limits are 7 each of Northern Pike and Walleye. Each team may weigh-in 5 of each of these 2 species.

**The Adult-Child** Tournament will also have a 7 White Bass boat limit in addition to the Northern Pike and Walleye boat limits. Adult-Child teams may weigh-in 5 of each of these 3 species.

**The Walleye Widow** Tournament boat fish limit will be 7 Walleye, 3 Northern Pike & 3 White Bass. Walleye Widow teams may weigh-in 5 Walleye, 2 Northern Pike and 2 White Bass.

**The minimum size limits** in all tournaments for Northern Pike is 20 inches, for Walleyes 15 inches, (exception; the Adult-Child has no minimum fish size requirements).
