

# LAKE REGION ANGLERS ASSOCIATION EAST BAY TOURNAMENT

SATURDAY JUNE 2nd, 2018

## LOCATION

East Bay Boat Landing

## FISHING AREA

Outing boundaries will be all navigable waters on Devils Lake east of Hwy 20 only. All boats will leave the ramp under a single file controlled start beginning with the boat registered #1.

## FISHING HOURS

The outing fishing hours will run from 8AM to 3PM.

**ELIGIBILITY.** Persons of any age are eligible to enter but one team member must be of age 18 years old or older. An eligible fishing team shall be made up of 1-2 or 3 persons. All persons must be members of LRAA.

## REGULATIONS

All contestants must observe US Coast Guard and ND Game & Fish Dept. rules, regulations, laws and license requirements. Life preservers must be worn when boat is on plane. All teams are responsible for their fish following the outing. Contestants are reminded that the "Spirit of the Rule" will prevail in all judgment cases.

## REGISTRATION—ENTRIES—WEIGH-IN—PRE-REGISTRATION REQUESTED

Teams must register prior to the outing scheduled time. No late entries will be allowed. Each team will undergo a boat check and be issued a team number. At the weigh-in one member of the team must deliver their number to the scoreboard, even if the team does not have any fish to weigh. The team may then load out their boat and proceed to weigh-in their catch.

## AQUATIC NUISANCE SPECIES INSPECTION

All boats must be inspected for ANS prior to doing any fishing or entry into a LRAA outing. Anglers will be required to sign-off on a ANS questionnaire form during registration prior to fishing in LRAA outing.

## ENTRY FEES

Entry fee shall be \$25.00 per team. Checks should be made payable to LRAA. In the event of cancellation due to inclement weather the Outing will be held the following Sunday. If the Outing is cancelled all entry fees will be refunded. The Outing is limited to 49 boats. Listen to local radio stations for cancellation and rescheduling information.

## SCORING

Team standings shall be determined by a total weight of their chosen 5 northern pike and 5 walleye. The northern pike must be a minimum length of 20 inches and the walleye 15 inches. The team limit will be a total of 7 Walleye and 7 Northern Pike. Once the 7th fish of tournament designated species are placed in the live-well the teams fishing day will be complete. Any ties will be determined by the largest walleye. There will be no early weigh-in unless arrangements have been made with Outing directors.

## PRIZES

Two plaques per team will be awarded to the top 5 teams plus one plaque for the largest northern and walleye per team. Cash prizes will be awarded to the top 3 teams based on 75% of the entry fees received. Payout shall be as follows—1st place 50%, 2nd place 30%, 3rd place 20%.
